Proposals for new housing must be of high quality and designed to reflect the character and distinctiveness of the villages of Repton and Milton. They must demonstrate how they meet the following:

**Reflect the design principles in the Village Design Statement.** 

□ Identify with the local character to create a sense of place appropriate to the location.

**Consideration of context and character.** 

Appropriateness of the building styles to the historic context as a listed building and/or within the Conservation Areas.

□ Integration of new proposals into the village and landscape setting, including the provision of grass verges or open spaces, where appropriate. A replacement with 2 - two storey dwelling is over- development of the site 9 2019 0113 – Proposed single storey rear extension, with eaves of 2.270 metres and maximum height of 2.740 metres extending 4.449 metres from the rear wall at Holly Bank Cottage, Broomhills Lane, Repton

9 2019 0028 – The widening of vehicular access to 40 Main Street, Repton 9 2019 0055 – The erection of extensions at 40 Askew Grove, Repton

**RESOLVED**: There would be no comments on the other planning applications.

# 2692/19 COUNTY, DISTRICT AND PARISH COUNCILLORS' REPORTS

a) District Councillor Stanton gave details about the Pancake Race taking place on Shrove Tuesday in Swadlincote and invited Repton to put a team forward. District Councillor Stanton also informed the Council about the Festival of Transport stating that there was a lot of support for the event and that Repton were welcome to put a team in the Soap Box Derby.

b) District Councillor Smith informed the Council that the footpath at Repton Bottom between Hartshorne and Bretby had now been cleared.

c) Councillor Thomas stated that we had not heard anything from the District Council about the recommendations for the play equipment on Mitre Fields. District Councillor Smith gave his apologies for this. Councillor Thomas also questioned what was the criteria for repair regarding the pavements. It was decided to take up the issue with County Councillor Ford.

d) Councillor Thompson reported that there was lot of dog defecation on Monsom Lane public footpath and a new bin should be located here. Councillor Thompson had had a request asking if anything could be done to improve the lighting on the road up to the Den. Councillor Mc Ardle to send an email to Councillor Thompson with contacts for the lighting.

Councillor Thompson expressed concern about the drilling of bore holes in a field on Pinfold Lane; he also questioned what was behind the drilling and was permission need. District Councillor Stanton would make further enquiries.

e) Councillor McArdle reported that following an accident on Springfield Road the damaged litter bin had still not been replaced.

f) Councillor Dickson reported back from the Repton Area Forum;

Health Walk on Thursday's at Willington

Dog fouling, there will be a Keep Britain Tidy Campaign within the next two weeks. SDDC will be distributing signs around the village.

Mount Pleasant poplar trees, the landowner has been requested to trim the trees.

Police have been doing speed checks in Milton. There have also been a lot of complaints about vehicles obstructing access in Milton and Repton. Road Traffic Order Consultation will be out in next three weeks.

# 2693/19 CLERK'S REPORT

a) The request by a resident to use the Broomhills car park on the 8<sup>th</sup> of June was agreed to.

b) A resident who had been given two burial plots in lieu of work done for the Council several years ago has asked if these can be returned and exchanged for a cremated remains plot free of charge. The council agreed to this request.

c) The request by the WI to use the Pavilion on 1<sup>st</sup> July from 6.30pm-9.00pm was agreed for a charge of £20.00. It was also agreed that £20.00 would be a standard charge for further requests.

d) Clerk reported that funding of £1400.00 had been granted for a new street light.

e) The request for the Council to supply litter pickers was granted.

f) The site clearance request for some trees to be removed by Cameron Homes was discussed, the Parish Council did not have the power to object unless the trees had been planted by the Parish Council.

#### 2694/19 CHAIRMAN'S ANNOUNCEMENTS

The Chairman presented Susan Reilly with a bouquet of flowers and on behalf of the Council thanked Susan for all her hard work and support.

The Chairman reported that there had been an article in the Burton Mail about the new village hall.

#### 2695/19 COUNCILLORS' ELECTIONS

The Clerk will be attending a training session about the May Elections. Councillor Thompson suggested publishing details of Election in Parish Magazine, website etc. The Chairman stated that she was going to put information in the Parish magazine about the Elections

#### 2696/19 SDDC CONSULTATION ON LOCAL GREEN SPACE PLAN

Councillor Thompson reported that the consultation should be consistent with the NDP and he would draft a response for circulation.

### 2697/19 VILLAGE SIGNS

Waiting for confirmation from DCC that the sign is suitable and also costings. The permission permit has been sent. A land search has been done, awaiting a response from Western Power

#### 2698/19 PLANTER FOR REPTON

Councillor Thomas presented information about putting planters by The Cross. It was suggested that 3 planters be situated on the paved area at the large end of the triangle. Councillor Thomas gave the Clerk details of the planters. **RESOLVED: The Clerk would submit a permit to DCC.** 

# 2699/19 FOOTPATH

It was reported that the stile at footpath 11 was in a bad state of repair and action was need to erect a barrier to stop motor bikes from using the footpath. It was stated that the style of barrier needed to be pushchair friendly. District Councillor Smith would forward details.

#### 2700/19 REPTON CROSS

It was reported that the actual Cross was a Grade 1 listed structure. Councillor Thompson confirmed that £20,000 had been earmarked to make the Cross stable. Councillor Steel presented details of a stonemason company that had worked with Heritage England. It was Highways responsibility to maintain the surround. Highway's report was expected from County Councillor Ford but had not yet been received but a previous report had stated that the cost to restore it would be around £30,000. **RESOLVED: The working group would contact Martyn Ford about proposals** for the surround of the Cross and also make enquires to Heritage England.

# 2701/19 BROOMHILLS FIELD & PAVILION

Authorisation had been received to upgrade the Pavilion. Further specifications were required. It was agreed that work should be dovetailed around users.

# 2702/19 REPTON VILLAGE HALL

Councillor Perks reported that work had now started on the new village hall with a projected completion of September 2019.

Two copies of the Memorandum of Agreement had been signed – one to be retained by each party. The Clerk had applied for the funds from the Public Works Loan Board – a rate of 2.57% over 25 years had been secured.

**RESOLVED:** The Parish Council would commence releasing the funds upon receipt of the letter of intent from Repton Village Hall Company.

#### 2703/19 NEIGHBOURHOOD PLAN PROGRESS REPORT

Councillor Thompson raised the issue of an appropriate way of advertising the referendum. Information would be sent to all residents. The Bursar, Repton School, said a banner to advertise the referendum could be organised.

#### 2704/19 TABLE TENNIS TABLE

The siting of the outdoor table tennis table at The Mitre Field was discussed. It was felt that it should not interfere with the other equipment and that an appropriate surface was required.
